Currently, there is no clear and unified definition of the term "parliamentary oversight." Legal scholars provide various approaches, which causes difficulties and confusion in understanding. Therefore, it is appropriate to develop terminological, theoretical, and conceptual foundations of parliamentary oversight based on the country's historical and governance context. Providing a precise definition of this term in legislation will prevent varied interpretations.

Scientific research on parliamentary oversight and the practical implementation of the recommendations contributes significantly to the development of this field. It is also important to establish legal and procedural mechanisms to regulate cooperation between parliamentary oversight institutions, local government bodies, citizens' self-governing institutions, and other civil society organizations.

President Sh.M. Mirziyoyev emphasizes that, "Parliamentary committees and commissions should play a key role in identifying shortcomings in ministers'

Expanding the practice of presenting the positions of party factions regarding the oversight-analytical activities of the committees of the Legislative Chamber is also essential. Ensuring the rule of law and strengthening legality requires raising public legal awareness and culture. In this regard, improving citizens' legal knowledge can establish public oversight over parliamentary oversight and enhance accountability. Currently, national legislation does not specify what actions the Legislative Chamber or the Senate should take following a parliamentary inquiry. Introducing a mechanism to express confidence or no confidence in the government will enhance the effectiveness of parliamentary oversight and strengthen the parliament's authority.

Additionally, establishing a dedicated parliamentary oversight committee operating within a specific scope will improve the effectiveness of this field. Parliamentary

According to Article 116 of the newly revised Constitution of Uzbekistan, the Cabinet of Ministers is accountable to the Oliy Majlis and the President [1]. To improve the effectiveness of parliamentary oversight, draft government economic decisions should be reviewed and approved by the Legislative Chamber. Such a mechanism, which ensures that unapproved decisions do not have legal force, increases the efficiency of decisions in the economic sphere.

In conclusion, parliamentary oversight guarantees citizens' rights and legal interests, ensures the effective implementation of laws, and evaluates whether government, state, and economic officials fulfill their duties honestly and accurately. Strengthening the parliamentary oversight institution, identifying existing problems, and developing solutions are urgent tasks.
